Minutes of Ryarsh Parish Council Meeting held in the Davison Room, Ryarsh Village Hall on Monday 11th April 2022 at 8.00pm

1. APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies were received and accepted from Cllr I Emson (illness) and J Sutton (work commitments) and Borough Councillor Montague. There were no declarations of Interest.

2. MINUTES

It was **RESOLVED** that the Minutes of 14th March 2022 be approved and signed as an accurate record by Cllr McKinlay.

3. EXTERNAL REPORTS

- (a) County Councillor Hohler
- KCC are trying to help with the traffic problems in Dover. This was not just due to issues with P&O. Bad weather meant one freight ferry was damaged and out of service and another one was stuck in Calais. The Police were very efficient.
- Cllr McKinlay said it was appalling that no facilities were provided for lorry drivers caught up in the delays. Cllr Hohler explained that modern lorries had toilet facilities in them, but Cllr McKinlay said this did not explain why bottles and bags of waste were left on verges. Water bottles should also have been supplied.
- It was noted that Kent is missing out on facilities and lorry parking.
- KCC made it clear to Government that documents would be checked outside Kent to prevent delays.

(b) Borough Councillor Kemp

 Electric charging points for cars are being installed, starting in Tonbridge Car Parks which have electricity. This is being rolled out as part of TMBC's Green Agenda.

(c) Police

Cllr McKinlay attended a Police and Crime Commissioner meeting last week on TEAMS. The Commissioner is concerned about the way electric scooters are being used. He is also very concerned that police always being blamed for things not happening. For example, if a speed limit is asked or something needs doing on highways, KCC say the police won't support the proposals. The Commissioner said he would support proposals if they were needed.

The Commissioner has produced a good report on the safety of women and girls. The police had not realised how much people were worried about being out at night on their own but are now aware.

4. PLANNING

(a) Plans Received for Comment

i. TM/22/00448/FL - Farm Land South Of Brook House, Roughetts Road - Total of ten handmade timber glamping pods for guests along with recycling/waste, cycle storage, a reception, a reading room, an outdoor play area, a communal BBQ hut and a barrel sauna. One parking bay per pod located next to each pod is proposed along with an additional 6 bay parking/turning area which includes 1 electrical vehicle charging point and 1 accessible parking bay. Each guest pod will have a small area of decking to the front where they can enjoy the sun and soak in the surroundings. Also intended are associated footpaths and landscaping of the site

The applicant attended the January meeting and showed everyone at the meeting what it was about. They then withdrew that application and this is a revised version. The proposals were well thought out, thinking about the environment, thinking about people around them and making sure facilities were there. Very little has changed between the first application and this one. It was hoped the site would bring more visitors to Ryarsh.

The Parish Council heard representations from members of public at the meeting:

- The land is on a flood plain which is not addressed at all well in the application.
- If the flooding on the land is addressed it will push flood water into the property next door
- The applicants' land already floods
- Pollution from any cars and vehicles going into site will run into the stream as it is all soft drainage. The stream is healthy and well populated with fish.
- The footpath is to be moved but has already been moved once to the edge of the stream
- The drawings suggest the applicant owns the tree line but they don't it belongs to the neighbouring property and the fence is on the other side
- The applicant states that the trees are soundproofing but they are not. Most are more mature trees with no branches for 10-12 feet so they provide no shelter. They shed their leaves every year and will provide no sound proofing during that time
- The adjacent property was not consulted by TMBC. The property will have noise, sound, light pollution – including noise and smell from the BBQ. The hill bounces noise to the neighbouring property and the cottages across the road.
- Footpath flooding is usual during the winter but they will still be open. Between September and February, you can barely access the field.
- There are no time limits set, so there could be noise pollution in the early hours of the morning.

The resident confirmed he has submitted his response to TMBC.

TMBC are not legally obliged to notify all properties near an application site. A one month delay for responses was requested for the Ryarsh Protection Group to consider and respond. TMBC deal with the time for responses but the Parish Council has been told there will be no extensions when a time limit has been set. Cllr Kemp said that if there is a real problem, the dates are not set in stone. Due to the concerns, and if she is in time, she will request that the application goes to Committee. Residents who submit a response will then have the opportunity to address the Planning Committee, but this is not an extension of time.

The Parish Council will consider the application which has been made, and not speculation as to applications which could be made if this was approved. The Parish Council circulated details through i's email list and by advertising the Agenda. All applications are available on the TMBC website and residents can sign up to be notified of any applications in the village.

The Parish Council did not previously record any objections to the first application, but at this meeting have heard issues including potential flooding, pollution noise, site boundary, issues with time limits etc. It was noted that the Environment Agency have expressed their concerns.

The Jubilee event finishes at 5.30pm when it will still be light.

Cllr Betts agreed to get a price for a machine to be located on the field that would provide a light display.
